Beer and Alcohol License Application

*****Applications must be submitted to the city offices for review, at least 2 weeks before the application can be approved by the City Council.***

An annual alcohol license fee of **\$150.00**, for each class of license, is required in addition to any other business license fee. Beer and alcohol licenses are issued in the name of the business owner or operator.

Beer and alcohol licenses are issued in accordance with Centerfield City ordinance *Alcoholic Beverage Control 3.05*, and Utah "*Alcoholic Beverage Control Act*" Title 32B. Applications may be made for the following 6 classes of beer and alcohol license.

1. Class "A" retail licenses:
 - a. Entitles the licensee to sell beer on the premises licensed in original containers for consumption off-premise in accordance with the Utah Alcoholic Beverage Control Act.
 - b. This class of license is appropriate for grocery and convenience store type establishments.
2. Class "B" retail licenses:
 - a. Entitles the licensee to sell a patron beer in original containers and/or wine served on-premise for consumption by a legal patron on-premise in conjunction with the sale of food in accordance with the Alcoholic Beverage Control Act.
 - b. This class of license is appropriate for dine-in restaurant establishments.
3. Class "C" retail license:
 - a. Entitles the licensee to sell beer in original containers, draft beer, wine, and/or alcohol on-premise in conjunction with the sale of food in accordance with the Alcoholic Beverage Control Act.
 - b. This class of license is also appropriate for restaurant establishments that make specialty beer (micro-brewery with food service).
4. Class "D" retail license:
 - a. Entitles the licensee to sell alcohol for consumption on-premises in accordance with the Alcoholic Beverage Control Act.
 - b. This class of license is appropriate for bars or clubs.
5. Class "E" retail or wholesale license:
 - a. Entitles the licensee to manufacture, warehouse, store, and sell an alcoholic beverage for off-premise consumption in accordance with the Alcoholic Beverage Control Act.
 - b. This class of license is appropriate for beer manufacturing and beer distribution facilities.
6. Class "F" temporary license:
 - a. Entitle the licensee to sell beer for on-premise consumption for a period of time not to exceed thirty (30) days. This class of license is non-renewable during a calendar year.
 - b. This class of license is appropriate for special events.
