- 2. **Responsibility to Report Changes.** The Undersigned Property Owner(s) and "House-Sitter(s)" agree o be responsible to report any changes concerning the information, or representations, on this application within 30 days of such change.
- 3. <u>Centerfield Municipal Code.</u> The Undersigned Property Owner(s) and "House-Sitter(s)" agree to be bound by the Business License Ordinances, as well as all of the other relevant Ordinances, Resolutions, and Regulations (currently or subsequently enacted or adopted by Centerfield City) application to this application.
- 4. **Representations.** The Undersigned Property Owner(s) and "House-Sitter(s)" represent that the following are true and correct to the best of their knowledge:
 - a. That the "House-Sitter(s)" are family members, or relatives of the Property Owner(s);
 - b. That the "House-Sitter(s)" are not paying rent or lease payments to the Property Owner(s);
 - c. That all information listed above in this application is accurate;
 - d. That this application is not being used to illegally avoid paying a business license fee;
 - e. That we agree to comply with all Centerfield City ordinances and other requirements;
 - f. That we agree to be responsible to report any changes concerning the information, or representations on this application within 30 of such change; and
 - g. That we recognize that knowing providing false information, or representations, or failing to report changes to information, or representations is potentially a civil and/or criminal violation and could be enforced as such.
